2. **Security deposit:** for one year amounting to 10 % of the total order value.
3. **Payment:** 100 % shall be made within 30 days after receipt and acceptance of material and successful installation, at our end in good condition.
4. **Comprehensive warranty:** Comprehensive warranty of 12 months to ensure satisfactory/flawless functioning of the stores to give the desired result. The comprehensive Guarantee/Warranty shall be applicable and binding on successful tenders. Initial 1 year Warranty should be given.
